



**TERMS AND CONDITIONS**

- ✓ All qualified companies are entitled to one (1) GLN valid for five (5) years. The subscription is renewable every Five (5) years thereafter.
- ✓ The subscription fee is non-refundable and non-reusable.
- ✓ A company who wishes to avail of two (2) or more GLNs will have to apply for a Regular GS1 Membership Subscription (subject to the rules and regulations of GS1 membership subscription).
- ✓ You accept the Data Privacy Policy and GS1 Activate Data Provider Agreement of GS1 Philippines found on its website, as well as the Terms of Use of the Data Out Solutions as you have given Data Recipient access to the GS1 Data Out services.
- ✓ You agree to maintain a correct record of all your location data, and keep this information up to date with GS1.
- ✓ All companies are required to submit the list containing the entities to which each GLN is assigned.
- ✓ In the event of a subscriber not declaring the correct information at the time of application or eventually found it to be incorrect, GS1 Philippines reserves the right to reject the application, suspend or cancel the subscription.
- ✓ While the GLN has been assigned to you, it remains the property of GS1 Philippines and is available only as long as you use the GLN according to the rules and regulations of GS1 Philippines and you pay the appropriate fees.
- ✓ Should you cease to use the GLN assigned to you for any reason, the GLN should be surrendered to GS1 Philippines by means of a formal letter. Surrendered GLN may be reallocated by GS1 Philippines. By signing this agreement, you undertake to indemnify GS1 Philippines against all claims and demands (and any expenses thereof) which may be made against GS1 Philippines should you allow your GLN to be used by any third party of for illegal purposes, or upon terminating your subscription, or continue to use the GLN without the consent of GS1 Philippines.
- ✓ Should you wish to re-apply for a GLN, you would be regarded as a new subscriber.

**LICENSE AGREEMENT**

1. **We \_\_\_\_\_, apply to GS1 Philippines, Inc. for a Global Location Number (GLN).**
2. We agree to abide by the rules and regulations of GS1 Philippines and terms of the License Agreement which in general requires the licensee to use the GLN given; not to permit its use to any other person or organization; to use only the 13-digit GLN issued by GS1 Philippines, Inc.
3. We acknowledge that if we fail to observe the GS1 Philippines rules, or any term of the License, the License may be terminated.
4. We further acknowledge and agree that our right to use the GLN ceases immediately upon termination of our subscription together with this licensing agreement, or if we otherwise infringe the intellectual property or other rights of GS1 Philippines, Inc., we will be liable to GS1 Philippines, Inc. for any loss or damage to it as a result.
5. Notwithstanding any termination of the License or our License Subscription by GS1 Philippines, Inc., we agree that the provisions of paragraph four (4) above will continue to be in full force and will be binding on us.
